

Occupational Health & Safety Policy

The key principles underpinning our policy are:

- 2. Eliminate, or otherwise reduce so far as practicable, the risks of injuries, diseases and ill health.
- 3. Promote and maintain a culture of safety and wellbeing.
- 4. Integrate consultation and communication through the development, implementation, and review of our OHS framework.

To achieve these, the following objectives have been established:

- Commitment to Continual Improvement of Occupational, Health and Safety (OHS) performances and standards within the business.
- Commitment to reduce OHS Risks and Hazards.
- Commitment to consult and gain workforce participation in OHS matters.
- Complying with all OHS/WHS legislation and other requirements which are relevant to the context of our organisation.
- Making our commitment to Health and Safety visible to all interested parties.
- Provided resources and appropriate training to ensure employees have the competence to conduct local risk controls.
- Determine authority, responsibility and accountability for the development and control of programs and perform assigned work duties.
- Setting measurable objectives and targets which will be monitored.

To achieve these objectives, we shall act to:

- Ensure participation at all levels in decisions concerning one's own work to ensure that the workplace is safe and without harm.
- Provide safe plant, equipment and work environments.
- Provide and maintain written hazard and risk management processes including risk registers, safe systems of work and management plans.
- Provide information, instruction, training and supervision to workers and contractors as is necessary to ensure continued mutual cooperation, health and safety.
- Conduct regular audits to enable continual improvement and ongoing compliance.
- Provide incident management process to assist in investigation, corrective action and identification of competency and training requirements.
- Provide support and assistance to workers including injury management programs to assist effective early return to work.
- Communicate this policy to all existing employees and to new employees when they commence with Codmah.

In support of our Objectives, and to demonstrate our commitment to Health and Safety, we maintain and continuously improve a Management System in accordance with the requirements of ISO 45001:2018.

This policy together with the measurable objectives and targets will be reviewed on an annual basis to ensure that it remains relevant and suitable to the operations of Codmah.
